HEREBY ORDERS AS FOLLOWS:

From the date of signature of this Order and in implementation of the provisions of article 9 of Law No. 99/014 of 22 December 1999 cited above, “Centre for Research on Democracy and Development in Africa” (CEREDDA), with head office in Buea, P.O Box 396, Fako Division is authorised as a Non-Governmental Organization in Cameroon, for a period of five (05) years, renewable.

2. This Non-Governmental Organization has as objectives:

- to inform and encourage discussion on problems of Africa and the activities of Panafrican organisations;
- to promote a culture of research, policy analysis and advocacy in Cameroon and Africa;
- to carry out research on all issues related to the democratization process in Africa.
